They will submit their name without a referral name via e-mail to helpcommunity@familysearch.org.

AWARDS AND PRIZES: One new contributor and the person that referred them will be selected *at random* to receive one \$100 Visa gift card each. Additionally, one new contributor that was *not* referred by a friend will be selected *at random* to win one \$100 Visa gift card.
